**Sunborn Finance Oyj- Amendments and waivers requested in a written procedure initiated on 15 May 2020 have become effective**

On 15 May 2020, Sunborn Finance Oyj (the "**Company**") instructed Nordic Trustee Oy (the "**Agent**") to initiate a written procedure for the Company's EUR 50,000,000 senior secured bonds with ISIN FI4000292750 (the "**Bonds**") in order to request (the "**Requests**") that the bondholders agree to vote in favour of certain waivers and amendments of the terms and conditions of the Bonds, as set out in the notice of written procedure (the "**Notice of Written Procedure**").

The Notice of Written Procedure is available on the Company's website ([www.sunborn.com/press](http://www.sunborn.com/press)) and on Stamdata ([www.stamdata.com](http://www.stamdata.com)).

As announced on 16 June 2020, a sufficient number of votes was obtained in the abovementioned written procedure to form a quorum, and a requisite majority of the votes cast in the written procedure were in favour of the Requests, subject to certain conditions being met before 15 July 2020 as set out in Section 5 (*Condition*) of the Notice of Written Procedure

On 25 June 2020, the Agent confirmed to the Company that the abovementioned conditions had been satisfied and thus the amendments and waivers set out in the Requests have become effective as of that date.
